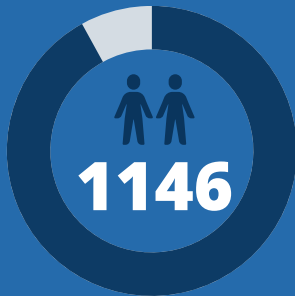


WHAT WE'VE BEEN DOING

BPG organized **13 Events**, covering **10 states of Brazil**



05/09 | Virtual Meeting

Wellington Oliveira and Luiz Claudio Garé, represented BPG at a meeting with **Sérgio Garcia, Customs Operations Coordinator for the Federal Revenue (COPAD/RFB)**, to discuss the program "Remessa Conforme", which provides simplified processing for the internalization of products from abroad through e-commerces **with the payment of simplified tax**, on the condition that the platform is committed to combating the Illegal Market.

09/10 | Meeting | São Paulo State Secretariat of Justice

The BPG President, Wellington Oliveira, along with Edson Vismona, President of FNCP - National Forum to Combat Piracy, and Marcella Pasternak Kuzolitz, Government and International Relations Analyst at ÁPICE - Association for Sports Industry and Commerce, attended a meeting at the São Paulo **State Secretariat of Justice and Defense of Citizenship** with the Secretary, Dr. Fábio Prieto, and his Executive Secretary, Mr. Raul Cristiano. The meeting aimed to discuss **new actions to combat the illegal market in the state of São Paulo** involving PROCON and IPEM, covering the physical and, especially, the digital market.

26/10 | Workshop | Fighting Intellectual Property Crimes: International Dialogues

BPG participated in the workshop "Fighting Intellectual Property Crimes: International Dialogues", the event organized by **USPTO** and **IACC**, with the support of the **US Customs and Border Protection** and the **Brazilian Federal Revenue**, was held in the city of Santos, state of São Paulo.

On that occasion, Wellington Oliveira, was a speaker and the association also had its members represented during the **Trade Fair**, training around **70 authorities**, including public agents from Brazil and the USA, in the recognition of counterfeit products.
